Evacuation/Fire Drill

An evacuation of all facility / building / school occupants to a designated <u>outside</u> assembly area. A complete accountability of all occupants will be conducted.



Shelter/Tornado Drill

The relocation of all facility/building/school occupants to a designated <u>inside</u> best available area of refuge. A complete accountability of all occupants will be conducted. (earthquake, hazmat, severe weather)



LOCKOUT

"Get Inside, Lock Outside Doors" Lockout is called when there is a threat or hazard outside of the school building. A complete accountability of all occupants will be conducted.



LOCKDOWN

"Locks, Lights, Out of Sight" Lockdown is called when there is a threat or hazard inside the school building. A complete accountability of all occupants will be conducted.



HOLD

"Hold in Your Classroom" "Clear the Halls" Remain in your classroom until further instructions is given.
