### APPROVED EXPENDITURES

The Student Activity Fund Policy and Procedure manual has never intended/attempted to list every permissible or non-permissible expense. There will always be something not listed one way or another as new expenses questions come up from year to year. The Principal as the Student Activity Fund Custodian should determine if the requested use is an appropriate use of student funds.

If an audit were to raise a question about an expense, the Principal will need to be able to justify the use of funds and the positive impact on the students of their respective school. As a general rule, funds raised by students should not be used for “Teacher/Coach” expense only. Students should be the direct recipient of funds raised by students.

- 1) Artist-in-residence program expenses
- 2) Assemblies/speakers
- 3) Assertive discipline program expenses
- 4) Athletic equipment and supplies
- 5) Athletic event officials, workers and security
  - Any compensation for District employees are to include 38% benefit costs paid directly to Oklahoma City Public Schools
- 6) Bank Charges
- 7) Banquet/reception expenses for students
- 8) Building operation expenses
- 9) Building supplies expenses
- 10) Building equipment expenses
- 11) Camp Fees
  - Cheerleading, student council, football, etc.
- 12) Classroom Equipment
- 13) Classroom supplies, materials and books
- 14) Class/Club Clothing
- 15) Clothes (coats, shoes etc.) for needy students
  - Using donated fund receipts
- 16) Club/Organization refreshments, parties, luncheons, picnics, etc.
  - allowed only if entire club/organization is invited
