Online enrollment must be completed by October 31st. To login to the enrollment site, go to www.afenroll.com/enroll. Type in your SSN as your user id. Your PIN will be the last four digits of your SSN and the last two digits of your birth year with no space in between.

- If you do not want to make any changes to your current medical, vision, or dental plans, you do not have to enroll or do anything for your coverage to stay the same.
- If you are planning to add a dependent, please provide documentation showing the dependent's relationship, i.e. birth certificate or marriage license. The deadline for all dependent documentation to be turned in is **Tuesday**, **October 31**, **2019**.
