

January 19, 2021

- Students in grades PK-4th will Return to Campus for in-person learning in A/B setting for remainder of the month of January.
- Additional small groups of students will return to campus for in-person learning:
 - SPED Self-Contained Classrooms (4 days a week; Monday is remote; Tuesday-Friday is in-person)
 - Alternative Education Students (Putnam Heights, Emerson North & Emerson South) will transition to the A/B setting
 - Students in our HOPE program will transition to the A/B setting
- Children in Workplace Program will continue for children of employees
- Students in grades 5th-12th will continue with Remote Learning.



Through federal CARES dollars, **air ionization systems** are being added to each building's HVAC system which help maintain healthy indoor learning environments by replenishing oxygen, filtering air and through ionization to remove or destroy airborne bacteria, particles and viruses, such as COVID-19.



Through a partnership with OCCHD and Total Wellness, OKCPS will begin to provide free voluntary rapid **COVID-19 testing for all OKCPS staff** and members of their household who are over age 18 at seven district sites. OKCPS will also work with OCCHD to deploy the COVID-19 vaccine to staff when it's available.



OKCPS will also launch an **enhanced site-based contact tracing and reporting protocol** on January 4, which is guided by public health officials at the CDC and Johns Hopkins University.
