Parent Involvement Policy

A. POLICY INVOLVEMENT

Jefferson Middle School will:

1. Annual Meeting

2. Flexible Meeting Opportunities

- Offer a flexible number of meetings (morning/evening).
- Provide, when possible, transportation, child care, or home visits, as related to parental involvement.
- Various meetings will be scheduled throughout the school year and at different times to maximize parent involvement. Notifications will be sent through email, letters, and phone calls.

3. Parent Participation in Planning

- o Involve parents in an organized, ongoing, and timely way in the planning, review, and improvement of Title I programs, including this policy.
- Parents are welcome to become part of the Title I planning team.

4. Parent Information

Jefferson Middle School will provide parents with:

- a. Timely information about Title I programs.
- b. A description of the curriculum in use, academic assessments used to measure progress, and proficiency levels expected of students.
- c. Opportunities for meetings to provide input and participate in decisions about their child's education.
- Copies of the Title I plan are available in the main office, the parent resource room, and on the school website.

5. Parent Feedback

- o If the schoolwide program plan is not satisfactory to parents, the school will submit parent comments to the local educational agency.
- Parents are encouraged to raise questions or concerns with any member of the Title I planning team.
