


NON-CDL VEHICLES

School Vehicles Used to Transport Students: What is Allowed?

The rated capacity of a school bus is determined by the original manufacture and can be found on a sticker or plate inside the bus. The bus is certified by the manufacturer for the rated capacity and cannot be changed or altered by anyone other than the manufacturer. The rated capacity directly affects the compartmentalization of the school bus.

14 Passenger Rated School Buses

Drivers operating a yellow school bus rated for 14 passengers or less plus the driver and the Gross Vehicle Weight Rating (GVWR) of 26,000 pounds (lbs) or less are not required to have a Commercial Driver's License (CDL). These drivers do not fall under the federal mandate for drug & alcohol testing. Districts may elect to have a policy requiring drivers to submit for drug & alcohol testing.

14 Passenger Rated Activity Bus

Drivers operating a multi-function school bus rated for 14 passengers or less plus the driver and the Gross Vehicle Weight Rating (GVWR) of 26,000 pounds (lbs) or less are not required to have a Commercial Driver's License (CDL). These drivers do not fall under the federal mandate for drug & alcohol testing. Districts may elect to have a policy requiring drivers to submit for drug & alcohol testing.

12+ Passenger Rated Vehicle Information

The use of vehicles with a manufacture capacity rating for 12 and above are illegal to transport students.


Federal law prohibits the use of vans or other vehicles with a seating capacity from the manufacture of 12 or more. Substantial penalties for schools, rental agencies and vehicle dealerships can occur if these vehicles are purchased or rented for use to transport students.

The rated capacity can be found on the Tire and Loading information sticker which is normally located on the inside driver's door.

Note: The passenger rating is determined by the vehicle manufacture and cannot be changed by anyone. It is illegal to remove seats from these vehicles to meet the mandated passenger requirement for student transportation. This would apply to both a school and/or dealership if the intent is to circumvent the mandated passenger rating for school transportation.




Pictured below is a 2016, 15 passenger rated Ford Transit Van. It is illegal under federal law to use this vehicle for student transport.

Pictured below is a 2016, 15 passenger rated Ford Transit Van. It is illegal under federal law to use this vehicle for student transport.


